## **LORENZ announces userBridge.10**

**This year's user conference will be held in Frankfurt, Germany // New:  
„eRegulatory Forum“ as top level panel discussion**

**Frankfurt/Main, 9. The Table Tutorials will take place in small groups to allow for more interaction among those attending that particular session. "We received some great feedback on our Table Tutorials in 2009, and what was successful last year should definitely be repeated again this year", said Wolfgang Witzel, President of LORENZ Life Sciences Group. "userBridge has become an annual event for those interested in the digitization of regulatory affairs, all in a relaxing atmosphere which provides ample time to communicate with one another and discuss what has been successful".
